Financial Report: Administrator Hartley reviewed the FPPA Report through the 4<sup>th</sup> quarter 2022. After discussion and questions,

### **Administrator's Report:**

FPPA year-to-date financial reports for the 4<sup>th</sup> quarter of 2022 are attached. FPPA is reporting 5.18% interest for the 4<sup>th</sup> quarter and -7.84% for the 1-year investment performance. The 5 year rate of return is 6.73%. The Board was reminded that the plan assets are commingled for investment purposes. Quarter 4 ending balance of \$3,795,300.22 was a decrease by \$742,906 from the beginning balance of \$4,538,206.70. Summit Fire & EMS Fire Protection District ("District") made no contributions in 2022, however, the Pension Fund received \$81,974 in Colorado State Matching Funds related to the District contributions made in 2021.

The 2022 annual audit of the Volunteer Pension Fund, which is a part of the District annual audit, is underway currently. The field work began in February and the work is still being completed. The goal is to have the draft audited financials completed for District Board review by April, 2023.
